

**MAY 10, 2022**

The Acadia Parish Police Jury conducted a public hearing before the regular meeting on Tuesday, May 10, 2022 at 6:00 PM before the regular Police Jury meeting, 3<sup>rd</sup> floor, Courthouse Building, Crowley, Louisiana, to hear comments on the following item:

1. Plans to consider adopting a resolution ordering and calling an election to be held in Sales Tax District No. 2 of the Parish of Acadia, State of Louisiana to authorize the renewal of a sales and use tax therein.

No comments were heard and the public hearing portion was closed by President Chance Henry.

THE ACADIA PARISH POLICE JURY met on the above date at 6:00 p.m., in the Police Jury Meeting Room, Courthouse Building, Crowley, Louisiana, in regular session with President, Chance Henry presiding.
