THE ACADIA PARISH POLICE JURY met on the above date at 6:00 p.m., in the Police Jury Meeting Room, Courthouse Building, Crowley, Louisiana, in regular session with President, Chance Henry presiding. At the request of the President, a prayer was offered and the Pledge to the Flag was recited in unison. The roll was called and final attendance was recorded as follows:

A motion was offered by Mr. Pat Daigle, seconded by Mr. Jimmie Pellerin, and carried unanimously, to dispense with the reading and approve the minutes of the May 10, 2022 Regular Meeting.

A motion was offered by Mr. Steve Comeaux, seconded by Mr. Jeffery Morgan and carried to approve the following amendments from the agenda:

a. Accept the additional bids for a tractor at LeGros Airport.

A motion was offered by Mr. Jeffery Morgan, seconded by Mr. Gordon Morgan and carried to table the discussion for additional funding for Mire Branch Water Corporation for the tower expansion until July, 2022.

Mr. Kyle Jones with Rostan Solutions gave updates about the debris removal from the waterway systems within the Parish. Looking at a 1-2 week timeframe. He also gave an update for the COVID Project from January 2020 – December 2022. Waiting for a dollar amount to be given. 30-45 day timeframe before the numbers will be given.

A discussion was held about Cedar Ranch Lane in Church Point, Louisiana. Sheriff K P Gibson said the road is private and no action was needed.

A motion was offered by Mr. Pat Daigle, seconded by Mr. Steve Comeaux and carried to adopt the revised merging certain qualifying voting precincts for Acadia parish from precincts created in plan 2A and the description thereof, and assignment of polling locations.

A motion was offered by Mr. AJ Credeur, seconded by Mr. Pat Daigle and carried to adopt a resolution for the revocation of the abandonment of 4th Street in Mermentau, Louisiana.

A motion was offered by Mr. Walter Andrus, seconded by Mr. Gordon Morgan and carried to repair aprons to all driveways along Northern Avenue from Rail Road tracks to the bridge, instead of entering into a CEA with the City of Crowley.

A motion was offered by Mr. Pat Daigle, seconded by Mr. Gordon Morgan and carried to move forward with replacing the camera system in the jail.

A motion was offered by Mr. Gordon Morgan, seconded by Mr. Jeffery Morgan and carried to go out for bid to update the roof at the parish jail.

A motion was offered by Mr. AJ Credeur, seconded by Mr. Pat Daigle, and carried to accept the bid from Prestige Restoration Services, in the amount of \$6,775.00 for the cleaning of the roof, cement and restriping of the parking lot of the Acadia Parish Health Unit in Crowley, Louisiana.

A motion was offered by Mr. Steve Comeaux, seconded by Mr. Jeffery Morgan and carried to accept the bid from Progressive Tractor & Implement Co in the amount of \$ 127,885.56 for the M-132 Kubota.

A motion was offered by Mr. AJ Credeur, seconded by Mr. Pat Daigle and carried to accept the bids for six months for supplies, materials and services for the different departments within the Police Jury system.

A motion was offered by Mr. AJ Credeur, seconded by Mr. Pat Daigle and carried to adopt a resolution for the CWEF Grant for Community Water Enrichment Fund for the 2022-2023 fiscal year.

A motion was offered by Mr. AJ Credeur, seconded by Mr. Pat Daigle and carried to adopt a resolution confirming Section 504 Assurance for CDBG Compliance.

A motion was offered by Mr. AJ Credeur, seconded by Mr. Pat Daigle and carried to adopt a resolution for Section 504 Grievance Procedures.

A motion was offered by Mr. AJ Credeur, seconded by Mr. Pat Daigle and carried to adopt a resolution for Section 504 Veterans Rehabilitation Act.

A motion was offered by Mr. Gordon Morgan, seconded by Mr. Walter Andrus and carried to reappoint Mrs. Alyssa Dogay to the Acadia Parish Library Board of Control for a term of five years.

A motion was offered by Mr. Jimmie Pellerin, seconded by Mr. Walter Andrus to nominate Mr. Nolton Senegal for the First Ward Drainage District to fulfill the unexpired term of Mr. Sanders Senegal until July 2022. Due to two citizens being nominated a roll call vote was taken and went as follows:

With the votes taken Mr. Jimmy Ancelet will be placed on the First Ward Drainage District to fulfill the unexpired term of Mr. Sanders Senegal until July 2022.

A motion was offered by Mr. Gordon Morgan, seconded by Mr. AJ Credeur and carried to reappoint Mr. Stephen Hamic and Mr. Wayne Wild to the Consolidated Gravity Drainage District #1 for a two year term.

A motion was offered by Mr. AJ Credeur, seconded by Mr. Gordon Morgan and carried to reappoint Mr. Tommy Faulk and Mr. Randy Thibodeaux to the Consolidated Gravity Drainage District #1 for a four year term.

A motion was offered by Mr. Gordon Morgan, seconded by Mr. Jeffery Morgan and carried to reappoint Mr. Reese Guillot and Mr. Wayne Baronet to the Sixth Ward & Crowley Drainage District for a two year term.

A motion was offered by Mr. Gordon Morgan, seconded by Mr. AJ Credeur and carried to reappoint Mr. Terry Istre and Mr. Chris Sarver to the Sixth Ward & Crowley Drainage District for a four year term.

A motion was offered by Mr. Walter Andrus; however, did not receive a second to appoint Mr. Anthony Clement for a two year term on the Sixth Ward & Crowley Drainage District. With no second the motion failed.

A motion was offered by Mr. AJ Credeur, seconded by Mr. Gordon Morgan and carried with exception of Mr. Walter Andrus who voted no, to reappoint Mr. Brad Core to the Sixth Ward & Crowley Drainage District for a two year term.

A motion was offered by Mr. AJ Credeur, seconded by Mr. Pat Daigle and carried to reappoint Mr. John Stefanski to the Acadiana Area Human Services District for a three year term.

The Monthly Permit office report was looked over.

The presentation of the monthly financials, which included budget to actual comparison on the general fund and all major funds was given by the CFO.
