THE ACADIA PARISH POLICE JURY conducted a public hearing on Wednesday, September 28, 2022 at 6:00 PM before the regular Police Jury meeting, 3rd floor, Courthouse Building, Crowley, Louisiana, to hear comments on the following item:

1. Discuss an ordinance to provide related to the waiver of land use regulations relative to permitting for mobile homes, recreational vehicles and other temporary housing in the event a Disaster Declaration that includes Acadia Parish, Louisiana and to provide for all matters relative thereto.

THE ACADIA PARISH POLICE JURY met on the above date at 6:00 p.m., in the Police Jury Meeting Room, Courthouse Building, Crowley, Louisiana, for a Special Police Jury Meeting with President, Chance Henry presiding. At the request of the President, a prayer was offered by Glen Howie and the Pledge to the Flag was recited in unison. The roll was called and final attendance was recorded as follows:

A motion was offered by Mr. Steve Comeaux, seconded by Mr. Pat Daigle, and carried unanimously, to move forward with the lowest bid from Elliot Construction from the bids received for the Hains Road Improvement plan.

A motion was offered by Mr. Jeffery Morgan, seconded by Mr. Steve Comeaux, and carried unanimously, to approve the Benjamin Estate Plat for Benjamin Estate Subdivision.

A motion was offered and carried by Mr. Steve Comeaux, seconded by Mr. Pat Daigle, to give Chance K. Henry, Acadia Parish Police Jury President, the authority to enter into an agreement with the Bank of Commerce as the Acadia Parish Police Jury Fiscal Agent.

A motion was offered by Mr. A. J. Credeur and seconded by Mr. Walter Andrus and carried unanimously to accept the Legros Memorial Airport 5-year Capital Improvement Plan (CIP) start year 2023.

A motion was offered and carried by Mr. A. J. Credeur and seconded by Mr. Walter Andrus to adopt a resolution stating the Acadia Parish Police Jury hereinafter referred to as "Sponsor", has completed an FAA and DOTD approved Master Plan, Action Plan, and/or Airport Layout Plan which outlines the specific future development of the Legros Memorial Airport.

The presentation of the monthly financials, which included budget to actual comparison on the general fund and all major funds was given by the CFO.
