The buffer zone will be 80 feet from the center of the road or 50 feet the right of way, whichever has the bigger buffer zone. Added to the ordinance was the Solar Farm permits. Beautification purposes, a Seven (7) foot minimum will be required inside the buffer zone as long as it does not conflict with any other laws, ordinances in place, public safety and security. Each fence shall have wood post and wire mesh fabric.
