THE ACADIA PARISH POLICE JURY met on the above date at 6:00 p.m., in the Police Jury Meeting Room, Courthouse Building, Crowley, Louisiana, in Regular Session with President Beau Petitjean presiding. At the request of the President, a prayer was offered and the Pledge to the Flag was recited in unison. The roll was called and final attendance was recorded as follows:

Jeffery Morgan was absent. Quorum present.

A motion was offered by Paul Ed Guidry, seconded by Pat Daigle and carried unanimously, to dispense with the reading and approve the minutes of the March 12, 2024 Regular Meeting as well as minutes of the April 2, 2024 Committee Meeting, as written.

There were no amendments to be added to the agenda.

A discussion was held by Corey Williams, Public Information Officer with SBA, to inform Jurors and the public on the Disaster Assistance to Louisiana Small Businesses Economically Impacted by the Severe and Extreme Drought – Economic Injury Disaster Loan. Corey expressed his sympathy with crawfish farmers and small business owners who were impacted by the severe drought on September 19, 2023 through December 5, 2023. The Small Business Administration received a declaration in all 64 Louisiana Parishes. The Small Business Recovery Center is located in Crowley at the old Train Depot. That center is open Monday through Friday 9:00AM to 6:00PM, and on Saturday 9:00AM to 1:00PM. Corey stated that interest does not begin to accrue until 12 months from the date of the first disaster loan disbursement and loan repayment begins 12 months from the date of the first disbursement. Businesses can borrow up to \$2,000,000.00 for their economic injury disaster loan needs. This loan can be used for paying employees, paying mortgages, and any expenses that are necessary to keep the business sustained during this recovery period. Corey stated there are no closing cost, no cost to apply and no pre-payment penalties. Interest rates for small businesses are fixed at 4% and nonprofit organizations at 2.375%. The loans are advertised up to 30 years. Deadline to apply for this economy injury loan is December 23, 2024 but Corey encourages business to apply as soon as possible to ensure businesses aren't severely impacted by the economic injury.

Paul Ed Guidry, Police Juror for District 6 asked Corey if there would be any loan forgiveness. Corey stated there would not be any loan forgiveness.

Glen Howie, Parish Attorney, held a discussion on adopting a resolution to approve execution of contract between Acadia Parish Police Jury and RNGC contingent upon review and recommendation of Acadia Parish Engineer and Acadia Parish Attorney. On April 9, 2024 Glen and President Beau Petitjean spoke to RNGC about revisions that Glen and Brett Bayard, Parish Engineer, recommend after reviewing the purchase agreement. This purchase agreement is in reference to capturing gas from the Landfill and selling it. Acadia Parish will receive 15% of the gross revenue as well as receive \$500,000.00 payment upfront with a 30-year contract with the option to extend if needed.

Paul Ed Guidry, Police Juror for District 6 asked Glen to clarify what his revisions or concerns would be with the current purchase agreement.

Glen stated that he is not finished reviewing the agreement but upon reviewing, section 3.6 talks about future expansion of the Landfill. Glen would like to get clarification on what the remedy would be on what Acadia Parish would gain if there was expansion of the Landfill. Glen is also questioning a section that talks about leasing and purchasing additional properties. Upon discussion with RNGC, it has been made clear that section will need to be revised. The current agreement has general information but some sections do not pertain to the Landfill. The final agreement will contain only information pertaining to the Acadia Parish Landfill. Glen will be reviewing the Louisiana State Statute to ensure the Acadia Parish Police Jury complies with leasing property.

Gordon Morgan, Police Juror for District 4, would like to ensure that this project would be fully profitable for Acadia Parish.

Glen stated that he will continue to review the agreement to verify there will be no cost to the Acadia Parish Police Jury.

Gordon would like clarification on what will happen with the equipment if the Acadia Parish Police Jurors decide to no longer us RNGC services.

Glen stated that in the agreement it does not have anything on that topic but assures that will be added.

President Beau Petitjean explained that the methane gas will become an issue at some point. Right now, at the Landfill, there is a "candycane" that the methane gas goes out of but at some point, the level of the

methane gas will need to be burned off. This system will continue to burn the methane gas.

Gordon asked if RNGC has completed any testing on the Acadia Parish Landfill to know if there is gas there now.

Beau explained that Mader Engineering presents a GEM Model that are variables on acreage, methane, and other items for scoring. The testing has already been completed.

Luke Dupré, Parish Attorney, held a discussion on the RNGC Agreement. Luke would like to help answer the question on build up. Luke stated that DEQ has certain regulations that are required to keep methane and carbon dioxide under a certain amount. After time, the Landfill will exceed that amount naturally from adding more waste. That would require the Acadia Parish Police Jury to install a flare at the Landfill, which could cost up to \$500,000.00. Entering into this agreement would save the Acadia Parish Police Jury on spending that amount. Luke states that in Section 2.6 of the agreement it says that the Acadia Parish Police Jury has the absolute right to direct Purchaser to cease all of the objectionable activity and to immediately conform its activities to this provision and in Section 2.7 it states the Acadia Parish Police Jury's interest always supersede the interest of RNGC.

A motion was offered by Pat Daigle, seconded by Gordon Morgan and carried unanimously to move forward adopting a resolution to approve execution of contract between Acadia Parish Police Jury and RNGC contingent upon review and recommendation of Acadia Parish Engineer and Acadia Parish Attorney.

NOW, THEREFORE BE IT RESOVED, that the Acadia Parish Police Jury, as the governing authority of Acadia Parish, hereby authorize the Parish President to conduct business, negotiate and sign all agreements or amendments effective April 9, 2024.

THUS DONE, SIGNED AND ADOPTED in regular session duly convened on this the 9th day of April, 2024, at Crowley, Acadia Parish, Louisiana.

A discussion was held on adopting a resolution authorizing the Acadia Parish Police Jury to designate LATCF funding toward a non-federal match/cost share project.

Ashley Leblanc, OHSEP Director, held a discussion and explained that LATCF is Local Assistance and Tribal Consistency Fund that was available following COVID that Acadia Parish was eligible for. The Acadia Parish Police Jury received \$100,000.00 and now has to allocate where those funds will be used. Ashley stated that based off of the categories that are eligible, the best fit would be the Non-Federal Match/Cost Share. That would go towards the window replacement at the Acadia Parish Court House.

A motion was offered by Paul Ed Guidry, seconded by Walter Andrus and carried unanimously to move forward adopting a resolution authorizing the Acadia Parish Police Jury to designate LATCF funding toward a non-federal match/cost share project.

RESOLUTION

LATCF FUNDING TOWARD A NON-FEDERAL MATCH/COST SHARE PROJECT

Whereas, The American Rescue Plan appropriated \$2 billion to Treasury across fiscal years 2022 and 2023 to provide payments to eligible revenue sharing counties and eligible Tribal governments, and Section 103 of Division LL of the Consolidated Appropriations Act, 2023 made additional funding available from LATCF funds unclaimed by eligible revenue sharing counties after January 31, 2023 or unobligated Treasury administrative funds, across fiscal years 2023 and 2024 for payments to eligible revenue sharing consolidated governments, for use on any governmental purpose, except for a lobbying activity.

Whereas, The purpose of LATCF is to serve as a general revenue enhancement program. As outlined in the Guidance for the Local Assistance and Tribal Consistency Fund, recipients have broad discretion on uses of funds and may treat these funds in a manner to how they treat funds generated from their own local revenue.

Whereas, As a general matter, recipients may use funds to cover costs incurred on any eligible use, including costs incurred from March 15, 2021. In the Guidance for the Local Assistance and Tribal Consistency Fund, Treasury provided a non-exhaustive list of examples of activities that may fulfill a governmental purpose.

Whereas, Specifically, recipients may use funds to cover costs of expenditures related to Non-Federal Match/Cost Sharing Requirements.

Now, Therefore Be It Resolved, Acadia Parish Police Jury does hereby designate the LATCF awarded funds in the amount of \$100,000 towards the Non-Federal Match/Cost Share of the Replacement of the Courthouse Windows Project.

Discuss with possible action adopting a resolution to move forward with a four (4) day - ten (10) hour workday for Acadia Parish Road Department Employees

Pat Daigle, Acadia Parish Police Juror for District 7, asked if this was going to be on trial program.

President Beau Petitjean stated that this can be a Pilot Program as discussed in the April 4, 2024 Committee Meeting. Beau stated this Resolution is to allow the Acadia Parish Road Department employees to be more productive and will be more cost effective for Acadia Parish.

Gordon Morgan, Acadia Parish Police Juror for District 4, asked how would going to a 4-day, 10-hour work week be more cost effective.

Beau explained that having more hours in a work day will help the Road Department employees work for longer periods of time in between their required breaks allowing them to be more productive.

Corey Vincent, Road Manager, held a discussion to state that working 4 days a week means that is 1 day with no traveling on the equipment. A 40-hour work week is accomplished within 4 days.

Gordon asked Corey why the Road Department no longer leaves equipment out on job sites. Gordon stated that in the past, farmers would allow the Acadia Parish Road Department to leave their equipment on the farmer's property to save on traveling.

Corey stated since he has been employed with Acadia Parish, the Road Department has had three windows shot out on the equipment. A grader that was parked near Corey's house had the tires cut. That grader tire was \$4000.00 dollars. Corey made the decision to stop leaving equipment on site to save on damages.

Bryan Borill, Secretary Treasurer, stated there were tires shot out on Quarter Pole Rd. as well as batteries stolen at that location.

Gordon stated that all employees of Acadia Parish are paid with tax payers' dollars. Those tax payers are working 5 days a week and expect the employees they are paying to also work 5 days a week. Gordon stated when he adds all these new Fridays minus the 6 Fridays they are already off, that equals 65 days a year the Road Department will be off. Gordon asked Corey what will happen on days that it is raining?

Corey stated that nothing will change from how the Road Department handles rainy days now. They still work during the rain.

Gordon stated there is no way the Road Department can be very productive in the pouring rain when it is thundering and lightening.

Corey agreed but stated that the employees don't stop.

Beau stated all Jurors including himself will evaluate going forward if the 4-day work week is effective and more productive.

Gordon stated that he answers to the taxpayers and to the constituents that elected him and the continents he has spoken to, are having trouble understanding how this will save Acadia Parish money.

Paul Ed Guidry, Police Juror for District 6, suggested to Corey to have a break down for the taxpayers to show them how exactly the employees will be more productive with the 4-day work week. Paul stated the employees are going to have to work hard to show taxpayers they are getting the work done in those 4 days.

Gordon asked what would happen if this 4-day work week does not show effectiveness.

Beau stated that if the Jurors will reevaluate and go back to a 5-day workweek if that is necessary.

Walter Andrus, Acadia Parish Police Juror for District 1, held a discussion to suggest that the jurors should let constituents know if there is an issue where the employees aren't able to work due to equipment not working. Walter stated that he will begin asking the Road Department for reporting showing when equipment was done to ensure the employees are working as much as they can. Walter also suggest showing reports on how much work employees got done.

Gordon stated he received a call from an employee in another department asking if that department could go to a 4-day work week.

Beau stated this resolution is for the Road Department only.

Beau held a discussion to let all taxpayers know that every Juror makes decisions that are in the best interest of the taxpayers. Beau would like to reassure all taxpayers that this 4-day work week will be evaluated and ensure productivity and cost effectiveness. Beau stated this decision is not to give the Road Department a day off on Fridays. It is to give the employees a 40-hour work week in 4 days.

A motion was offered by Troy Lantz, seconded by Pat Daigle and carried, adopting a resolution to move forward with a four (4) day - ten (10) hour workday for Acadia Parish Road Department Employees. Gordon Morgan, District 4, was in opposition of the 4-day work week.

A motion was offered by Troy Lantz, seconded by Pat Daigle and carried to move forward with a four (4) day ten (10) hour work day for Road Department employees.

The resolution was declared adopted on this, the 9th day of April 2024.
