THE ACADIA PARISH POLICE JURY conducted a public hearing on Tuesday, October 8, 2024, at 6:00 PM before the regular Police Jury meeting, 3rd floor, Courthouse Building, Crowley, Louisiana, to hear comments on the following item:

1. Discuss with possible action to amend the current Ambulance Ordinance (Ordinance No. 1128).

Bill Nevitte stated that he does see any reason to amend this ordinance. Bill stated that amending this ordinance would leave the residents of Acadia Parish with no choice when choosing an ambulance service. Bill stated that if three ambulance services wanted to be in Acadia Parish, then that should be allowed

Acadia Parish Police Jury President called on Acadia Parish Police Jury Attorney, Glen Howie, to explain that is not what the amendment is stating.

Glen Howie explained that his understanding of this ordinance amendment is not limiting Acadia Parish to one ambulance service. It is stating that if one ambulance service goes out of business or withdraws from proving services to Acadia Parish, the remaining ambulance service will have the opportunity to give the Acadia Parish Police Jury a proposal stating how they would take care of the parish.

Walter Andrus, Acadia Parish Police Juror for District 1, stated that his understanding of the ordinance amendment is also that if an ambulance service withdrew from Acadia Parish, the budget would remain the same to protect Acadia Parish. Walter stated that this amendment is not to limit Acadia Parish to only one provider.

A motion was made by Walter Andrus and seconded by Troy Lantz and carried unanimously to move this item to the Regular Police Jury Meeting.

A motion was offered by Pat Daigle, seconded by Walter Andrus and carried unanimously to add an item to the agenda to discuss with possible action adopting a resolution to reallocate ARPA funds that were initially committed to broad band build out in Acadia Parish.

A motion was offered by Walter Andrus, seconded by Troy Lantz and carried unanimously to add an item to the agenda to discuss with possible action to amend the current Ambulance Ordinance (Ordinance No. 1128).

A discussion was held by Kayla Segura with LSU Ag Center and 4-H Youth Development Extension Agent to speak on behalf of the program and introduce the staff. Kayla thanked the Acadia Parish Police Jury for their continued support.

Acadia Parish Police Jury President, Beau Petitjean, introduced the new Office of Homeland Security & Emergency Preparedness Director for Acadia Parish, Kaitlyn Sonnier.

A discussion was held by Jimbo Petitjean, Acadia Parish Tax Assessor, to discuss the list of assessments for Acadia Parish totaling \$416,165,697.00 which does not include public utilities.

A motion was offered by Walter Andrus, seconded by Kirk Guidry and carried unanimously to approve and certify the list of assessments for Acadia Parish totaling \$416,165,697.00 which does not include public utilities.

The Acadia Parish Police Jury sat as a board of review for an appeal that was submitted to the Acadia Parish Tax Assessor.

Ryan Broussard held a discussion to appeal against the assessment of his property in Crowley. Ryan stated he received a letter explaining that his home property tax would be increasing by 130 percent. Ryan stated that Lafayette Parish did a parish wide increase of only 30 percent. Ryan stated he is appealing this assessment due to the large increase.

Jimbo Petitjean, Acadia Parish Tax Assessor, held a discussion explaining that he and Mr. Broussard had an in-person meeting to discuss the assessment of his property. Jimbo stated that he assigned a member of his staff who was familiar with evaluating property an area that they did not live in so there was no personal connection to the assessment. Mr. Petitjean provided the Jurors with a picture of Mr. Broussards home for them to review. Mr. Petitjean stated that the explanation for his assessment to jump is because the property was undervalued for quite some time. Mr. Petitjean explained that at this time, they have the properly assessed at \$149,000.00 including the land. That is \$50.00 a square foot. Mr. Petitjean stated that he requested a copy of Mr. Broussard's homeowners insurance policy but Mr. Broussard did not provide that to him. Mr. Petitjean stated that Mr. Broussard said he may have some square footage that could be removed from the assessment. Mr. Petitjean stated that Mr. Broussard never provided him with that information. Mr. Petitjean stated that everyone else in Mr. Broussard's neighborhood is valued at \$60-\$70 a square foot while he is valued at \$50.00 per square foot. Mr. Petitjean stated that in 2008 the house sold for \$115,000.00. In 2011 it was quit claimed for \$134,000.00 then Mr. Broussard bought it at a cash sale for \$63,000.00 and the property stayed at that value until the reassessment this year.

A motion was offered by Kirk Guidry, seconded by Troy Lantz and carried unanimously to deny the appeal for property re assessment.

Mr. Petitjean reviewed the assessment data for 2012 – 2024. The assessment data was shown on screen.

A discussion was held by Wendy Harrington, Executive Director for Acadia Convention Visitors Commission. Wendy introduced herself and is happy to work with the Acadia Parish Police Jury with upcoming projects she has planned.

Jimbo Petitjean, Acadia Parish Tax Assessor, held a discussion regarding a matter he forgot to mention in the earlier discussion about Mr. Broussard. Mr. Petitjean stated that the people of the State of Louisiana passed a law called a "Phase In" stating that if the assessment goes up more than 50 percent in an assessment year, then the taxable value will only increase by 25 percent per year until you get to the full value of the assessment for four years. Mr. Petitjean stated that Mr. Broussard is eligible for that Phase In. Mr. Petitjean gave an example of if last year, it was valued at \$100,000 and this year it is valued at \$200,000, then it would only be taxed at \$125,000.00 for the first year, \$150,000.00 for the second year, \$175,000.00 for the third year, and then \$200,000 for the fourth year. Mr. Petitjean stated that there will be many people who are eligible for the Phase In.

A discussion was held by Luke Dupre, Acadia Parish Police Jury Attorney, to explain ordering and calling an election to be held in Sales Tax District No. 2 of the Parish of Acadia, State of Louisiana, to authorize the renewal of a sales and use tax therein. Luke stated that this tax is a road tax for repairing, constructing, improving, and maintaining Aadia Parish roads and bridges. Luke stated that this is the main fund that funds road development in Acadia Parish. Luke stated that these taxes last for 15 years before they are renewed. The tax was passed in 1997 with 63 percent, and again in 2012 with 73 percent. Luke stated that this tax has never failed before. This tax expires in April of 2027. Luke stated that the reason it is on the agenda now is because if it does fail, then we will need to hold another election to get it passed so the Acadia Parish roads can be maintained and repaired. The election will be on March 29, 2025.

Acadia Parish Police Jury President, Beau Petitjean, asked Luke to clarify if anything is changing with this tax renewal.

Luke stated that nothing is changing. This is just a renewal of what is already in place.

A motion was offered by Pat Daigle, seconded by Troy Lantz and carried unanimously to call for a public hearing on November 12, 2024, at 6:00 PM at its Regular Meeting to consider adopting a resolution ordering and calling an election to be held in Sales Tax District No. 2 of the Parish of Acadia, State of Louisiana, to authorize the renewal of a sales and use tax therein. A roll call vote was offered and carried unanimously.

A discussion was held by Luke Dupre, Acadia Parish Jury Attorney, to inform the public of the facts justifying the Public Hearing on the Acadia Parish Police Jury salary raises. Luke stated that being elected as Police Juror takes time from each jurors' jobs and families. Jurors are visiting different departments within Acadia Parish, attending meetings to discuss Acadia Parish business while also making sure each constituent's needs are met. Luke stated that if leaders aren't paid enough then they would not look like the average citizen of Acadia Parish and only the rich would be able to afford to be a Police Juror. Luke stated that Jeff Davis Parish recently had a salary increase due to Jurors not being able to afford to spend their free time serving their parish. Luke presented to the public a comparison of other parish Police Jury salaries. Luke presented the following:

Jeff Davis Parish has 32 thousand people, and they pay their Jurors \$1250.00 a month. Vermillion Parish has 57 thousand people, and they pay their Jurors \$1600.00 a month. Rapides Parish has 127 thousand people, and they pay their Jurors \$1600.00 a month. Cameron Parish has 56 hundred people, and they pay their Jurors \$1100.00 a month. Evangeline Parish has 32 thousand people, and they pay their Jurors \$1600.00 a month. Allen Parish has 22 thousand people, and they pay their Jurors \$1200.00 a month.

Luke stated that Acadia Parish has 65 thousand people, and the Acadia Parish Police Jurors are paid \$500.00. Luke stated that this raise should have been given 20 years ago. Luke stated that the plan that this administration has proposed is \$1600.00 per month. It is legal and supported by sound, local government principles, commensurate with the time each Juror spends serving Acadia Parish, and it allows the parish to have a government of the commons.

A discussion was held by Walter Andrus, Acadia Parish Police Juror for District 1, to state that he receives \$950.00 a month. Walter stated he believes that the Acadia Parish Police Jury should be brough to the standard of all the other surrounding parishes. Walter stated that someone brought to his attention that when he was elected, he agreed to attend two meetings a month and that has not happened. The Acadia Parish Police Jury does not hold a Committee Meeting every month. Only a Regular Meeting. Walter stated that if they held two meetings a month, they would be at twenty meetings for the year, and he believes they have only held 14 meetings. Walter stated that he does see the need for an increase but would like to take some time to think about salary raises.

Luke stated that the amount of money that each juror takes home a month is different due to insurance and social security. Some might take home \$950.00 while others may take home \$500.00 due to deductions. Luke stated that Jurors are Jurors all 30 to 31 days a month. Not just the days they are expected to hold meetings.

A motion was offered by Pat Daigle, seconded by Walter Andrus and carried unanimously to all for a public hearing on November 12, 2024, at 6:00 PM at its Regular Meeting to consider a proposed ordinance to adopt a compensation schedule for Police Jurors which will be in effect from January 1, 2025, until December 31, 2028, with the monthly salary being \$1600.00 plus an additional \$200.00 for the President.

A motion was offered by Troy Lantz, seconded by Kirk Guidry and carried unanimously to authorize the President to sign an Addendum to the ARPA Subrecipient Agreement with the Town of Iota extending the agreement to October 30, 2026.

A motion was offered by Pat Daigle, seconded by Jeffery Morgan and carried unanimously to authorize the President to sign an ARPA Subrecipient Agreement with the Mire Branch Water Corporation allocating \$1.17 million dollars for the improvement of the regional water system.

A motion was offered by Walter Andrus, seconded by Pat Daigle and carried unanimously to authorize the President to sign an ARPA Subrecipient Agreement with the North of Crowley Water Corporation allocating \$400,000 for the improvement of the regional water system.

A discussion was held by Jay Domingue, REACH 4, to discuss the reallocation of ARPA funds that were initially committed to broadband build out in Acadia Parish. Jay stated that in 2020 and 2021, Acadia Parish allocated 2 million dollars to bring broadband to the parish and the Acadia Parish Police Jury asked several providers of broadband to go before the jury to make a proposal. In 2021 there were two providers that were awarded funds contingent on receiving funds from the GUMBO program. Jay stated that in that meeting, Reach 4 proposed 4 projects and LUS Fiber proposed 2 projects while Acadia Parish was going to commit 20% per project provided that the company won the project. Jay stated that in July of 2022, Reach 4 was the only internet provider that received GUMBO awards from the state which was around 1 million and Acadia Parish was committed to 20%. Jay stated at that time, no one else was awarded so during the September 2022 meeting, Jay asked the Acadia Parish Police Jury if they are allocating those funds to

broadband, then Reach 4 would like to continue the proposed projects. Jay stated that the Jury voted unanimously to approve. Jay stated that he later found out that LUS was allowed to resubmit their proposal with an amendment for GUMBO funds and as a result gave them a higher score and was awarded the funds. Jay stated that he would like the new administration to move forward with giving Reach 4 the funds that were initially allocated to broadband. Jay asked the Acadia Parish Police Jury to not award LUS the funds because they misrepresented themselves on their application.

Shaun Grantham, Acadia Parish Police Jury CPA, held a discussion stating that this agenda item is in regard to the reallocation of funds based on board minutes and what has been approved verses what has been committed. Shaun stated that when looking at LUS and Reach 4, based on board action, the Acadia Parish Police Jury is going from 3 million to what they are paying LUS and Reach 4 and the difference to reallocate is 2 million.

Glen Howie, Acadia Parish Police Jury Attorney, stated that the allocation that the Acadia Parish Police Jury voted on was a 20% match of the GUMBO project. Glen stated that LUS did amend their application, but The Acadia Parish Police Jury only expends the 20% that was committed at that time. Glen stated that the allocation of funds is based off GUMBO awards in Acadia Parish have been directed that way and the monies that were committed to the projects have been paid to both internet providers.

Shaun Grantham, Acadia Parish Police Jury CPA, stated that all ARPA funds have been committed.

A motion was offered by Walter Andrus, seconded by Pat Daigle and carried unanimously to reallocate ARPA funds that were initially committed to broadband build out in Acadia Parish.

BE IT THEREFORE RESOLVED that any portions of the initial \$3,000,000.00 originally intended by the Acadia Parish Police Jury for use on broadband buildout projects in the Parish of Acadia are released from commitment to Broadband internet services and are to be reallocated to other projects qualifying for ARPA funds as determined by the priorities of the Acadia Parish Police Jury.

A motion was offered by Walter Andrus, seconded by Kirk Guidry and carried unanimously rescinding any ARPA allocation plan or informal agreement which tentatively assigned ARPA funds on a "per district" basis.
