WHEREAS the Acadia Parish Police Jury, LA and Rostan Solutions, LLC (hereinafter referred to as "Rostan", collectively referred to as the "Parties") entered into an agreement on December 1, 2021, for Rostan to provide certain Professional Services; and

WHEREAS the Agreement initially authorized a term of two (2) years with three (3) one-year extensions available upon mutual written consent of the Parties; and

WHEREAS the Parties executed the first one-year extension to extend the Agreement through November 30, 2024, in Amendment 2: and

Waste Connections would like to swap then Wednesday and Friday route. Clay explained that the Friday route is much longer than the Wednesday route so if they were to do the current Friday route on Wednesdays, that would allow their Fridays to be used for any issues that may come up during the week. Right now, with the Friday route being so long, whenever they are done with the route, they are not able to take care of any issues that may have arisen from the week. Clay explained that Waste Connections has contracted a company that will go door to door putting door hangers on trashcans and/or doors to let the public know that their trash day schedule is changing.

Acadia Parish Police Jury President Beau Petitjean asked for Waste Connections to confirm that the scheduled change WILL ONLY be the Wednesday route and Friday route.

Waste Connections confirmed that is the only routes that are changing. If someone currently puts their trash out on Wednesdays, they will start to put their trash out on Fridays. And If someone currently puts their trash out on Fridays, they will start to put their trash out on Wednesdays.

Acadia Parish Police Juror for District 8, Troy Lantz, asked Waste Connections if they will give everyone a grace period during the transition and pick up trash if the person forgot that their trash schedule changed.

Waste Connections reassured Troy that they would have time on Fridays to handle any issues that were brought to their attention.

Acadia Parish Police Juror for District 1, Walter Andrus, asked Waste Connections when this change in schedule would go into effect.

Waste Connections stated that September would be a good month for the schedule change, but they will need to make sure every resident is reached before the schedule is changed.

A motion was offered by Paul Ed Guidry and seconded by Walter Andrus and carried unanimously to approve schedule changes by Waste Connections to swap the Wednesday route with the Friday route to improve efficiency.

Acadia Parish Attorney, Glen Howie, held a discussion about the Bayou Des Cannes-Nezpique Gravity Drainage District board members petition that was filed. Glen stated that after extensive review of the LA statute (LA R.S. 38:1759), it is evident that the statute requires that when there is a competing petition for commissioners and drainage board members, the Acadia Parish Police Jury must appoint the members that present the petition with the most acreage in that district. The Acadia Parish Tax Assessor reviewed each petition and completed an assessment totaling the number of acres for each petition. Glen stated that his recommendation is that the Acadia Parish Polce Jury appoint the drainage board members with the most acreage in their petition.

Acadia Parish Police Juror for District 6, Paul Ed Guidry, asked for Glen to read what the statute says.

Glen read the statute LA R.S. 38:1759. "The police jury organizing the drainage district shall appoint five

commissioners in each district, two of the commissioners for the term of two years and three for the term of four years, and all selections or appointments thereafter shall be for the term of four years. The appointment of commissioners by the police jury shall be made upon the petition or recommendation of a majority in number of acres or a majority of the resident land owners in the district where the district contains forty or fewer land owners. Where more than forty land owners are embraced in the district, the appointment shall be made upon the recommendation or petition of twenty-five of the land owners of the district. Where there is a contest over the appointment of commissioners, the police jury shall give the appointment to those commissioners who are recommended by the land owners owning the greatest number of acres of land in the districts. In the absence of any petition or recommendation, the police jury may appoint commissioners in their discretion."

A motion was offered by Gordon Ray Morgan and seconded by Paul Ed Guidry while Troy Lantz opposed to appoint the Bayou Des Cannes-Nezpique Gravity Drainage District board members with the most acreage in the petition.
