Discuss with possible action amending the Code of Ordinances to repeal provisions regarding the defunct Landfill Commission; specifically to repeal Ordinance No. 759 and Ordinance No. 760; an ordinance to amend and repeal Article VII of Chapter Eight of the Code Of Ordinances of the Acadia Parish Police Jury to remove provisions regarding the Landfill Commission; to repeal all ordinances or parts of ordinances contrary thereto or in conflict therewith; and to provide for all matters relative thereto.
2. Discuss with possible action adopting a resolution ordering and calling an election to be held in Sales Tax District No. 2 of the Parish of Acadia, State of Louisiana, on Saturday, March 29, 2025, to authorize the renewal of sales and use tax therein.
3. Discuss with possible action a proposed ordinance to adopt a compensation schedule for Police Jurors which will be in effect from January 1, 2025, until December 31, 2028, with the monthly salary being \$1600.00 plus an additional \$200.00 for the President.
