Jessie Bellard, St. Landry Parish President, held a discussion regarding the Acadiana Regional Juvenile Justice District. Mr. Bellard is the Chairman for the Acadiana Regional Juvenile Justice District which consist of 9 parishes. The district will be building a 100-inmate facility that will house juveniles. Mr. Bellard states the location of this facility is unknown at this time. The state will be helping to fund the project. The Acadiana Regional Juvenile District is requesting \$1000.00 from each parish in order to proceed with the preliminary phases of this significant project. The funding will help cover essential start-up costs, including planning, administrative expenses, and preliminary site assessments. Mr. Bellards states that the Acadiana Regional Juvenile Justice District should know in January of 2025 if the Governor of Louisiana will award them the money to build this facility.

A discussion was held by Chris Dufour with RNGC Holdings, LLC regarding Renewable Energy Recovery Project at the Acadia Parish Landfill. Mr. Dufour states that RNGC has been working on the site and ordering equipment to properly start the project. Mr. Dufour states that his expectation is that by the 4th quarter of 2025, they will be able to deliver methane gas and pay the parish royalty payments.

Walter Andrus, Acadia Parish Police Juror for District 1, asked Mr. Dufour what amount is he expecting for the royalty checks to Acadia Parish for the methane gas.

Mr. Dufour stated the projection was around 1 million dollars a year.

A public comment was made by Julie Nolan. Ms. Nolan asked Ms. Grantham if the Health Unit would have a surplus of funds in 2025. Ms. Grantham stated that there would not be a surplus in that fund. Ms. Nolan asked if the funding for Animal Control comes out of the Health Unit fund. Ms. Grantham stated that Animal Control funding

does come out of the Health Unit fund. Ms. Nolan stated there are around 56,0000 people in Acadia Parish according to a census with Crowley having around 11,000 people, Rayne having around 7,000 people, and Church Point having around 4,000 people. Ms. Nolan stated that Crowley has their own shelter with 18 kennels, Rayne has their own shelter with 25 kennels, and the Parish has their own shelter with 17 kennels. Ms. Nolan stated that most of the animals that come into the Acadia Parish Animal Control are animals that came from Church Point because they do not have their own shelter. She would like to know if there is any possibility that the Acadia Parish Police Jury can add more kennels to the shelter to help house the animals.
