Discuss with possible action calling for a Public Hearing on May 13, 2025 to revise the Acadia Parish Hotel/Motel Tax Ordinance to reflect the Louisiana Revised State Statute.

Acadia Parish Police Jury Attorney, Glen Howie, held a discussion regarding the amended ordinance. Mr. Howie explained that Wendy Harrington, Executive Director of the Acadia Convention and Visitor Center, sent an e-mail about the need to update the ordinance, which is now reflecting 2% hotel motel tax, but the Louisiana State Statute says Acadia Parish has a 4% hotel motel tax. Mr. Howie explained the Police Jury will simply adopt a revision to our current ordinance to comply with the state.

A motion was made by Pat Daigle and seconded by Walter Andrus and carried unanimously to move this item to the Regular Police Jury Meeting Agenda.

Presentation of Proclamation commending Knights of Peter Claver and Ladies Auxiliary was presented.

A PROCLAMATION
Commending Knights of Peter Claver and Ladies Auxiliary

WHEREAS, the Knights of Peter Claver and Ladies Auxiliary is a distinguished Catholic fraternal organization founded on November 7, 1909, in Mobile, Alabama, and incorporated on July 12, 1911, by four priests of the St. Joseph's Society of the Sacred Heart and three dedicated laymen; and

WHEREAS, the organization was established to promote and advance the Catholic faith while fostering community service, unity, and charity among its members, embodying the principles of faith and service exemplified by its patron, St. Peter Claver; and

WHEREAS, the Junior Daughters division was established in 1930, ensuring the continued growth of faith and leadership among young women in the Catholic Church; and

WHEREAS, St. Peter Claver, born in Catalonia, Spain, in 1581, devoted his life to missionary work, arriving in Cartagena, Colombia, in 1610, where he ministered to enslaved Africans, providing them with spiritual guidance, compassion, and care, and was later canonized by Pope Leo XIII in 1888, with his feast day observed on September 9; and

WHEREAS, the Knights of Peter Claver and Ladies Auxiliary continue to honor his legacy by promoting social justice, education, and charitable works while fostering Christian values within their communities;

NOW, THEREFORE, We, the duly elected Police Jurors for the Parish of Acadia, on behalf of the citizens of Acadia Parish, do hereby recognize and commend the Knights of Peter Claver and Ladies Auxiliary for their steadfast commitment to faith, service, and community. I encourage all citizens to acknowledge their contributions and join in celebrating their legacy of compassion, unity, and leadership.

Governor's Office of Homeland Security and Emergency Preparedness to discuss the recent flooding event and give the public information on SBA (small business administration) loans that will be available. The Governor's Office of Homeland Security and Emergency Preparedness explained that the damages did not meet the threshold for individual assistance from FEMA.

Acadia Parish Police Juror, Walter Andrus, asked if they could provide the guidelines that would meet the criteria for individual assistance from FEMA.

Residents from Acadia Parish stated their concerns regarding drainage from the recent flooding event.

Bridgette Homer, Director of Homeownership Programs, held a discussion regarding Capital Area Financing Authority Program which provides down payment assistance for first time home buyers. Ms. Homer is requesting that Acadia Parish Police Jury continue to allow CAFA to offer this program in Acadia Parish. This is a program that is currently being offered in Acadia Parish and is no risk to the parish. The bond for this program is up for renewal and CAFA is requesting a resolution stating that this program will be available in Acadia Parish.
