THE ACADIA PARISH POLICE JURY met on the above date at 6:30 p.m., in the Police Jury Meeting Room, Courthouse Building, Crowley, Louisiana, in regular session with the President David Savoy presiding. A motion was offered by Mr. Robert Guidry, seconded by Mr. Ronnie Fabacher and carried unanimously, to make the following amendments to the agenda:

1. Add an item to the agenda- Adopt a resolution requesting federal and state government assistance to secure the installation of a permanent continuously reporting bayou stage gaging station on Bayou Plaquemine Brule near Interstate 10 or LA Hwy 13 and to provide for the development of all necessary hydrologic and hydraulic modeling required to forecast and report stages at frequent intervals on a daily basis.
2. Add an item to the agenda- Adopt the updated Acadia Parish Hazard Mitigation Plan.

A motion was offered by Mr. Ronnie Fabacher, seconded by Mr. Kerry Kilgore and carried, to dispense with the reading of the September 13, 2016 Regular Meeting minutes and approve them as written.

Mr. Scott Angelle introduced himself and announced his candidacy for United States Congress.

Mr. Gus Rantz introduced himself and announced his candidacy for United States Congress.

Mr. Mack Atteberry, resident of Acadia Parish, expressed concerns about Apex Clean Energy's proposed 48,000 acre wind farm in Acadia Parish. He stated that the project would include the construction and operation of 50 to 70 wind turbines that would stand 300 feet tall and be detrimental to the rice industry in Acadia Parish. He asked that the Police Jury pass a moratorium on this type of development until further research can be conducted.

No action was taken.

The Acadia Parish Police Jury sat as the Board of Review for Property Assessment for Acadia Parish. There were no appeals to review.

A RESOLUTION OF THE ACADIA PARISH POLICE JURY, ACADIA PARISH, LOUISIANA, REQUESTING FEDERAL AND STATE GOVERNMENT ASSISTANCE TO SECURE THE INSTALLATION OF A PERMANENT CONTINUOUSLY REPORTING BAYOU STAGE GAGING STATION ON BAYOU PLAQUEMINE BRULE NEAR INTERSTATE 10 OR LA HWY 13, AND TO PROVIDE FOR THE DEVELOPMENT OF ALL NECESSARY HYDROLOGIC AND HYDRAULIC MODELLING REQUIRED TO FORECAST AND REPORT STAGES AT FREQUENT INTERVALS ON A DAILY BASIS

WHEREAS, Bayou Plaquemine Brule and Bayou Wikoff are major drainage receiving streams that serve a significant portion of Acadia Parish, especially providing drainage for watersheds that encompasses Crowley, Rayne, Branch, Richard, Church Point and areas in between and around these municipalities and unincorporated communities; **and**

WHEREAS, the apparent increasing frequency of heavy rainfall events within these watersheds has led to severe and recurring flooding of property along and at great distances from the bayous over the past several years; **and**

WHEREAS, such severe flooding has resulted in the incalculable loss of buildings and property, great financial hardship for thousands of inhabitants, and untold human suffering; **and**

WHEREAS, climatologists and meteorologists advise that we should expect a continuation of increasingly more frequent intense rainfall events that lead to such flooding and human disasters; **and**

WHEREAS, the technology exists to monitor such conditions, predict their effects, and forewarn inhabitants and property owners of the onset of flooding many days in advance of such disasters; **and**

WHEREAS, monitoring, predicting and forewarning the public for days in advance of unstoppable inundation will save lives, prevent injuries, and preserve property otherwise destroyed by flooding ; **and**

WHEREAS, an official gaging station placed on Bayou Plaquemine Brule near Crowley coupled with data collected at the existing Mermentau River at Mermentau Gaging Station along with computer modeling and official updates of the bayou's hydraulics during severe weather will serve to forecast, forewarn and protect tens of thousands of Acadia Parish residents.

NOW, THEREFORE BE IT RESOLVED by the Acadia Parish Police Jury, Acadia Parish, Louisiana, in regular session duly convened that all FEDERAL AND STATE officials are urged to work together quickly to take the necessary steps to immediately secure the installation of an official permanent and continuously reporting government operated gaging station along Bayou Plaquemine Brule at Interstate 10 or LA Hwy 13, as appropriate for best results, and provide for the development of all necessary hydrologic and hydraulic modelling required to monitor, forecast and adequately forewarn the public at frequent intervals daily of the onset of minor, moderate, and major flood stage events; and

ANNUAL CERTIFICATION OF COMPLIANCE

WITH STATE OF LOUISIANA

OFF SYSTEM BRIDGE REPLACEMENT PROGRAM

WHEREAS, the Code of Federal regulations as enacted by the United States Congress mandates that all structures defined as bridges located on all public roads shall be inspected, rated for safe load capacity and posted in accordance with the National Bridge Inspection Standards and that an inventory of these bridges be maintained by each State; **and**

WHEREAS, the responsibility to inspect, rate and load post those bridges under the authority of Acadia Parish in accordance with those Standards is delegated by the Louisiana Department of Transportation and Development to Acadia Parish.

THEREFORE, BE IT RESOLVED by the governing authority of Acadia Parish (herein referred to as the Parish) that the Parish in regular meeting assembled does hereby certify to the Louisiana Department of Transportation and Development (herein referred to as the DOTD) that for the period 1 October, 2015 through 30 September, 2016:

1. The Parish has performed all interim inspections on all Parish owned or maintained bridges in accordance with the National Bridge Inspection Standards.
2. All bridges owned or maintained by the Parish have been structurally analyzed and rated by the Parish as to the safe load capacity in accordance with AASHTO Manual for Maintenance Inspection of Bridges. The load posting information that has been determined by the LA DOTD for all bridges where the maximum legal load under Louisiana State Law exceeds the load permitted under the operating rating as determined above has been critically reviewed by the Parish. Load posting information has been updated by the Parish to reflect all structural changes, and obsolete structural ratings or any missing structural ratings.
3. All Parish owned or maintained bridges which require load posting or closing are load posted or closed in accordance with the table in the DOTD Engineering Directives and Standards Manual Directive No. 1.1.1.8. All DOTD supplied load posting information concerning a bridge has been critically reviewed by the Parish Engineer prior to load posting.
4. All bridges owned or maintained by the Parish are shown on the attached list in the format specified by the DOTD. Corrections to data supplied to the Parish by the LA DOTD are noted.

These stipulations are prerequisites to participation by the Parish in the Off-System Replacement Program.

Juror Danny Hebert stated that he had received a call regarding a collapsed drain pipe located under the road in the proposed BG Estates Subdivision.

Mr. Mitch Studebaker, the developer for BG Estates Subdivision, stated that the drain pipe was not collapsed and due to discrepancies with the road he offered to obtain and maintain a \$50,000.00 bond for five years.

Mr. Brad Andrus, Parish Attorney, asked if the Planning Commission approved it and if the Police Jury could deny what the Planning Commission already approved.

Mr. John Stefanski, Planning Commission Member, stated that the Planning Commission's concern was that the drain pipe was not properly installed and that some areas of the pipe are deformed. He further stated that if it comprises the road it will happen soon and it is unlikely that the pipe will fail.

Mr. Karl Aucoin, Parish Engineer, stated that the BG Estates is a 24 lot subdivision located off of Rue Novembre. He also stated that there was an existing drainage lateral that was indicated on the preliminary plat and that the developer had changed the drain pipe and indicated such on the construction drawings. He also stated that the Planning Commission approved the construction drawings contingent upon a hydraulic study being conducted and that the installation of the drain was to manufacturer's standard. He further stated that the developer did not have the drain pipe inspected while installing it but that it was certified after installation by Mr. Ron Sarver. He stated that the drain pipe did show some bowing and deviation but he did not believe the structure would fail. He recommend that Mr. Brad Andrus develop an agreement or statement for bond.

If the pipeline companies attempt to circumvent the public hearing procedure they will be fined ~~ten thousand dollars (\$10,000.00)~~ Five Hundred and 00/100 (\$500.00) Dollars per day until the scheduled hearing.
